#### 2021 CSBPA SENIOR MIXED TEAM & DOUBLES STATE TOURNAMENT RULES

- 1. Participation shall be female & male bowlers age 50 & over who are members of a local association in the state of Colorado. NON-MEMBERS who reside in Colorado without a current USBC membership may enter by paying \$20.00 for a USBC Card.
- 2. The Tournament shall have a mixed team event (2&2 and 3&1), a mixed doubles event (1&1) and an individual handicap for ALL EVENTS.
- 3. All entrants shall use their highest average of 21 games or more 2020-21 season. If none are available, their 2019-20 average of 21 games or more or 2021 summer average 21 games or more. If none of these apply, they will bowl scratch.
- 4. Handicap 90% of 225
- 5. In the event of a mechanical failure, bowlers affected will be moved to the next available pair of lanes.
- 6. Score changes will be made in all cases of obvious calculation errors. House printout sheets will be official score sheet and will be held for 72 hours after event.
- 7. Any scores lost during bowling will be re-bowled.
- 8. No pacers permitted.
- All entry fees must be paid in full and accompany the entry form, payable to Colorado State BPA. Entry fee is \$25.00 per person, per event. (Lineage \$9.00, Prize Fund \$10.50, Expense Fee \$3.50 and \$2.00 onto all events).
- 10. All entrants' full names must be provided. NO NICKNAMES.
- 11. Tardy bowlers will start in the frame being currently bowled with zero for their missed frames. Use of ineligible bowler or incorrect average will nullify all claims for any prize of award.
- 12. It is each bowler's responsibility to verify their average whether submitted by the bowler, team captain or others. A final book or an average sheet with the association secretary's signature would be appreciated. If the submitted average is lower than the book average and results in a lower classification or more handicap, the score will be disqualified. If the submitted average is higher than the book average, prize winnings will be based on the submitted average. In the case of a team of two or more bowlers the average will be combined to determine of the correct total is higher or lower than the submitted total.
- 13. USBC RULES 319D & 319C are waived.
- 14. All prized fees will be returned 100%. The prize ration will be one (1) for every (5) five entries or major fraction of.
- 15. Prize money will be paid by the CSBPA within 30 days of the tournament by check in mail.
